1. The Contractual Partner hereby submits a binding application, subject to a charge, for registration with SupplyOn for the provision of SupplyOn Services in order to then be able to apply for use of the SupplyOn Services. Type and scope of the SupplyOn Services performed by SupplyOn are described in the applicable service specification.
2. The following documents form an integral part of this Master Contract and shall apply in addition to the provisions of the Master Contract for the provision of SupplyOn Services (can be viewed at [www.SupplyOn.com/contract](http://www.SupplyOn.com/contract)):
  - SupplyOn's General Terms and Conditions for SupplyOn Services (version 3.0, as at April 2007) (hereinafter referred to as "GTC")
  - Service Specification for SupplyOn Services for Supplying Companies (version 1.3, as at November 2011).
3. The Master Contract shall come about only by SupplyOn's acceptance of this application (§ 3 GTC). It shall remain at the discretion of SupplyOn whether to accept such application. The Contract shall commence on the date SupplyOn accepts the application. If SupplyOn accepts the application by sending an invoice, the commencement date shall be the invoice date.

Any extension of the contract shall be governed by §10 GTCs. In case of terminating this Master Contract prior to the Basic Term or the agreed upon Extension Period of a certain individual service the rules of this contract will apply until the end of the Term or the agreed upon Extension Period of the individual service.

4. The Contractual Partner shall inform its employees, the dependent legal units and affiliated companies as well as the respective employees thereof using or wishing to use the SupplyOn Service of the GTC and the other constituent parts of the Master Contract, and impose an obligation on them to observe the same.
5. Remuneration of the individual SupplyOn Services shall be based on the prices agreed at the time of application for the relevant SupplyOn Services (price agreement).
6. All SupplyOn Services shall be invoiced a full contract year in advance. The first invoice shall be issued directly after registration pursuant to § 3 GTC. If the Contractual Partner registers for further SupplyOn Services in the course of a contract year, a *pro rata* invoice shall be issued in advance until expiry of the respective contract year.

7. Invoices for the SupplyOn Services shall be based on the company data below.  
The Contractual Partner confirms the correctness of the information provided, and undertakes to update the relevant company data on the SupplyOn platform without delay.
